<p><b><i>Approval of Agenda</i></b></p>	<p>President Weidman requested a motion for the approval of the <b>October 14, 2020</b> Board Meeting Agenda as presented. <p><b><i>Action Items</i></b></p>	<p>President Weidman requested a motion for the approval of the Hybrid and Remote Learning Plan. Motioned by Weidman and seconded by Nash for the approval of the Hybrid and Remote Learning Plan.  <b>Yeas:</b> Weidman, Mack, Nash, Braden, Lacroix, and Strack.  <b>Nays:</b> Miller.  <b>Motion carried.</b></p> <p>Prior to the vote, Dr. Glickman, Superintendent, shared that the Safe Center will remain open for students in the Hybrid Model. The location will change from Prairieview School to Frederick School. The district will schedule one or more Remote Planning days prior to the start of the Hybrid Plan, to give the teachers time to get their classrooms ready. Board members were given time to ask clarifying questions and share concerns.</p>
